#### **TOWN CLERK'S REPORT**

### a) Accounts

The Clerk would be looking at additional grant funding opportunities to try and reduce the risk to the Council.

Discussion was held regarding the Speedwell Rooms. There was no update to be provided to this meeting but assurances were given that any decisions would be brought to Council for approval.
